1. Membership: Beatrice Bergemont

2. Other Reports/New Business: Mt Tam Florilegium by guest Mary Gilardi Mary described the project for the new members:
a. Mt Tamalpais is home to 1200 native species including more than $10 \%$ of all native plants found in California.
b. Six are found only here and over 50 are listed as threatened, endangered or rare.
c. Mt Tam is an internationally recognized biodiversity hot spot.
d. It has 10 times the number of plants per acre than Yosemite which is nearly 20 times as big.
e. One Tam is a collaborative effort between

- California State Parks
- Marin County Parks
- Marin Municipal Water District
- National Parks
- National Parks Conservancy
f. Our members will donate a digital image of their paintings to be used in One Tam's education and outreach programs.
g. The next collection date is Monday, May 24th at 10:30 a.m.
h. The Florilegium entry deadline has been extended to August 15, 2021
i. The next exhibit will be at Marin Art and Garden Center in conjunction with ASBA's 24th Annual International from September 19 to November 28, 2021.
